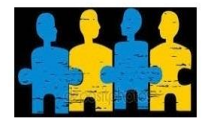

Introduction of the Solution Partners & Providers in Iran

The SP group, known in GS1 as Solution Partner & Provider, aims to interact with the software and hardware companies, providing the software required by potential customers in various areas of Apparel, Fresh Foods, Chemicals industry, etc.

This group started its activities in governmental and non-governmental organizations compliant with GS1 standards, helping to improve and augment complementarities, globalization of Iranian's SPs along with the other SPs in the field of IT which eventually results in creation of asset.

The plan's goal was to identify Iran's ability to start its work on the SP project. In this research, GS1 deployment kit was studied in the field of SP, and then a case study was conducted on the different countries that launched the project. The project involves different parts: market identification, identify of activities undertaken, GS1 articles and contents in the field of SP, identifying the weaknesses and strengths of GS1 Iran Organization(center?), threats and opportunities facing the organization (SWOT), and finally a road map for achieving these goals and the proposed levels of SPs. In addition, various revenue plans, marketing plans, loyalty plan, training plan and accreditation plan for assessing and reaching the roadmap were drawn up.

The issue of interactivity and synergy in the field of software companies raised as the first issue in the country by the GS1 Iran and many research works on three areas of

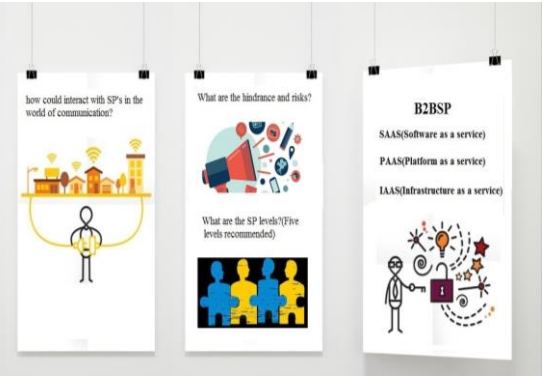
software, hardware and educational services have been carried out. The organization has been genuinely involved with interacting and creating synergies for two years.

Different levels of collaboration with SPs

The main goal of the SP programs is development of the market for the GS1's application with standards for the benefit of the entire value chain. According to GS1's SP1 activists, GS1 compliant solutions will be available on the market. On the other hand, through the SPs, one can be sure that all SMEs, global firms, retailers and SPs have made their own choices. The gained knowledge from the target market, along with the capabilities of GS1 Iran and analysis of business model patterns, resulted an offer by the organization on five categories of working model with respect to the existing conditions. It should be noted that SPs even need to be classified according to our target (entering in the industries). The following five categories which are named as SP levels are shown in the table below:

NO	Level Name	Description
1	SP1	Marketing, Analysis, Implementation for GS1 Iran
2	SP2	Solution (Software, Hardware, Training Services) compliant with GS1 standards
3	SP3	GS1 Iran's contractors in the development of the software platform of GS1 Iran
4	SP4	Joint venture with GS1 Iran in developing new business ideas or National Projects (We think as a Solution partner)
5	SP5	Providing services such as Barcode Verification and etc.

Partnership Agreement

National Center for Iranian Product and Service Number (GS1) and — Company

Article 1. The Parties of Agreement

For the purpose of creating, expanding, cooperation and educational, research and advisory services, this agreement was signed between the National Center for the Issuing of Goods and Services of Iran (Private Joint Stock), the registration number 458249 at Tehran, Jihad Square, at the beginning of Joybar Street, East Shahid Mirdadi Alley, No. 4 with Mr. Sayyed Hossain Paryab representative as CEO (referred to as "GS1 Iran"), and the hardware company named — to the registration number — to the address — with Mr. — as the Director The agent, (referred to as the "Company"), was agreed upon and signed.

By signing this agreement, the two sides will limit their efforts to expand national power in solving scientific-research problems to the subject of this agreement and achieve national self-reliance, and will refrain from any attempt in this regard.

Article 2 - Issues of agreement:

- ❖ Joint collaboration to provide specialized advice for promoting the activities of the hardware domain.
- ❖ Joint collaboration in order to organize and deliver training courses in accordance with GS1 standards to facilitate the processes of hardware companies.
- ❖ The company will perform the requirements of the National Center for Numbering according to the needs of the customers with the quality and cost.
- ❖ Each of the parties, products and services in accordance with the standards and strategies of GS1 will introduce its counterpart in the provincial and city centers.
- ❖ The price of the company's products and services in the event of the customer's introduction to the company will be determined by mutual agreement and agreement.
- ❖ Collaboration to establish interconnection of supply chains overseas in real time.
- ❖ Collaborate to facilitate the membership of the Hardware Company and profit from the benefits and opportunities of GS1.
- ❖ Planning for the GS1 expert or hardware companies in related sectors that are held around the world by GS1.
- ❖ Collaborate to promote the level of knowledge, information management and the empowerment of hardware knowledge.
- ❖ A permanent study of the latest scientific achievements and hardware industry technologies in the GS1 federations and collaboration to identify practical and useful applications.
- ❖ Collaboration for the sharing of hardware.

- ❖ Collaborate in educational and content areas through the media and better capture for GS1 capabilities, the level of knowledge of people about this system, as well as to highlight the achievements, powers and utilization of the coding system.
- ❖ Collaborate on introducing and promoting the GS1 coding system to customers and requiring the use of the GS1 system for all customers.

Article 3- Obligations of the Parties:

1. The parties are obliged to appoint one of their experts as a representative and introduce them in writing within 10 days after signing the contract.
2. The representatives of the parties are obliged to meet at least once a month and have the necessary planning and coordination.
3. All agreements reached between the deputies, the minutes are considered and examined by the relevant units and the results are announced on the contrary.
4. An agreement will be concluded for each activity agreed upon.
5. The financial obligations will only be created in the form of a separate agreement, and the exchange of this agreement will not create a financial commitment for the parties.
6. This agreement does not contain any financial obligations for both parties, and no one can claim from each other on the basis of this agreement or in the form of meetings under this agreement.
7. The company is not obliged to refer to this letter of understanding either in the name of the representative or the contracting party of GS1 Iran, or to refrain from studying in this way

Article 4- Duration of the Agreement:

The duration of the agreement's implementation of understanding from the date of its signature and exchange is equal to one years, and each party can issue a letter regarding the termination of the Agreement.

Article 5 - Appendices, copies and enactments of the agreement

This agreement is set forth in 5 articles and one note and in 2 copies with the decree and the credit of the unit and it will come into force for the parties from the time of its signing and exchange.

- Individuals must be re-accredited every three years

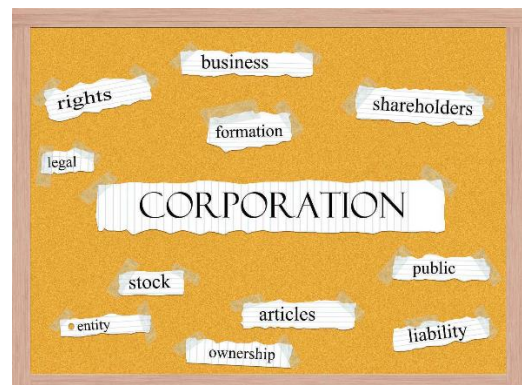
